PAP and Non-Invasive Ventilation Delivery, Setup, and Monitoring Regulation

Michael Purcell, Sleep Technology Group LLC presented some questions pertaining to PAP/NIV care in the home. Mr. Purcell is asking for clarification on who (CRT, RRT, or RCT) can be exempt from the regulations.

After review of each question below, the decision of the committee in respect to the questions concerning home administration. Licensure does not discriminate between CRT and RRT. They each are designated as a Respiratory Care Practitioner (RCP).

1. Program or change settings to a device with documented orders from the treating physician? **RCP**
2. Deliver a device to the home and instruct the client on the devices operations? **RCP**
3. Deliver and / or help client get a proper mask fit by actually touching and adjusting mask while on the client? **RCP**
4. Deliver and / or explain how to ensure the mask fits correctly without touching the client? **RCP**
5. Deliver, instruct, or explain how the device interacts with the body systems in clinical terminology? **RCP**
6. Deliver, instruct, or explain how the device interacts with the body systems in non-clinical terminology and they identify themselves as NOT being clinical? **RCP**
7. There is terminology in some of the literature that discusses monitoring. Does the person monitoring a patient need one of the designations above in a home setting if monitoring for compliance? **RCT**

Jerry Alewine mentioned to the committee of the upcoming SC Society of Respiratory Care Practitioners Summit, August 12, 2022 held at Newberry College.

Joel Livesay, RCP made a motion to adjourn at 10:42 am. Scott Simms, RCP seconded.
