## 7. Additional Skills Appearance:

Ryan Marovich, PA and Supervising Physician Dr. Habib Rizk

Dr. Gardner ask Mr. Marovich to explain what additional skills he was requesting, and how he was qualified and competent to perform these task as part of the care practice team. He also explained how once all information was given, the committee would need to take a vote, or may need to go into a private meeting to discuss it.

Tina Behles swore in Ryan Marovich, PA and his supervising physician Dr. Habib Rizk

Mr. Marovich discussed his education and job experience. He stated his additional skills request was for office procedures; pressure tube, and steroid injections. The procedure logs, from his past job were for over an 18 month period. During this time he had approximately performed 226 tubes and over 100 injections. He also taught how to perform these procedures for approximately 8 years. Time is important for the injections for sudden hearing loss, as injections have a 1 to 2 week window, so patients end up seeing a PA due to availability.

Dr. Rizk explained a big part of why they hired Mr. Marovich was his ability to perform these task, and he felt very confident in Mr. Marovich's ability to perform these task.

Ms. Gillespie stated Mr. Marovich was a past student of hers, and she had no problems approving him based on what she knows of his past training. Dr. Gardner asked if Ms. Gillespie would be bias, and she said no, as her vote was based on his ability and past training.

Dr. Gardner stated he had checked Mr. Marovich CPT Codes, and was impressed with his thoroughness, and asked if any other committee members had any questions.

Dr. Cook stated she did not question Mr. Marovich's ability to perform the procedure, but she questioned his skill set to determine if a person needed the procedure or not.

Dr. Rizk stated it was based on a sudden drop in hearing loss, and one can tell this from hearing test. Mr. Marovich explained that when he teaches the course, he includes the current AAO guidelines concerning when to perform and when not to perform the procedure.

Dr. Gardner asked if there were any further questions from anyone. Dr. McCallum agreed that Mr. Marovich was very accomplished and he had no concerns. Dr. Gardner ask if anyone feel the need for private meeting, and call for an execution session. No one did.

The motion was made to approve Mr. Marovich, PA additional skills request for pressure tube, and steroid injections. Mr. Roper approved the motion and Dr. McCallum seconded it, and the motion passes unanimously.

Dr. Gardner stated Mr. Marovich would receive paper approval soon, but his additional skills were approved as of today and he could begin preforming the procedures.

- 8. Consideration of Committee Vacancies None to Report
- 9. Committee Member Term Expiring None to Report
- 10. Chair Report and Administrator's Report
  - A) South Carolina Radiation Quality Standards Association (SCRQSA) certification, and should Physician Assistants acquire this for Radiology Scope of Practice (SOP)

Dr. Gardner stated the past view the committee had taken on this was that the site the PA was working at, the employer, or the primary supervising physician is responsible. Mr. Horner discussed what the nursing board did, and that DHEC said radiology needed certificates to perform operation of the equipment.

Dr. Gardner explained the Practice act for a PA and for nursing reads different. The Scope for PA is to assist and perform under the supervising physician, but a technician is there to run the machine. Running the machine is not part of the scope of practice for the PA. "Radiology" was not an issue, because the technician takes care of that part to insure patient's safety. Mr. Horner agreed and suggested that hospitals were wanting the nursing, to run the machine instead of the technician.

Dr. Gardner suggested a PA could submit a scope if they wanted to be the person running the machine. However the current Radiology Scope of Practice is for a task such as asset with a catheter tube, but not for running the machine and he didn't want to confuse the two.

Dr. Cook suggested they keep an eye on the possibility of a business who may be short staffed and push a PA to run the radiology machine when they are not certified to do so. Dr. Gardner suggested this also be brought up at the next board meeting, and did any committee member feel they needed to vote on this. The decision was made to not add the DEHEC certification to the PA Scope of Practice for radiology.

B) Submission of Modified Scope of Practice and Additional Skills to streamline the approval process

Ms. Pridgen explained there was a 13% increase in the last 6 months for Scope of Practice / Additional skills submitted for approval to the committee members, and was there any additional information that could be provided to the committee members to improve the process. Dr. McCallum stated there was an increase in cosmetic procedures, and something on the form that would show where the procedure would be performed at would be beneficial.

Ms. Pridgen suggested an area on the email reply that could hold a check box for "Accept, reject, and accept with amendments" so the decision the committee member made would be clear and eliminate some email exchange. Dr. Gardner and Dr. McCallum stated that would be okay. Dr. McCallum stated we could always reach out to them if we had questions.

Mr. Horner ask is there a way to handle some of the "weird" request he gets such as cool sculpting. Mr. Roper stated he always tells people to look at the PA approved task, or the pre-approved task on Scope of Practice. If a PA needs to perform something else they would need to submit an additional skills request to the board. Dr. Gardner agreed.

Dr. McCallum asked how the committee can verify if the physician can perform the task the PA is requesting to add. Dr. Gardner stated the physician's specialty tells a lot, and suggest they call the physician and ask how they feel qualitied to do this, and or they willing to bear the supervisor weight if something goes wrong.

Dr. Gardner asked if anything else needed to be discuss. All agreed there was nothing else.

Dr. Gardner asked if they liked the meeting being held by WebEx. All agreed they did. Decision was made to hold the next meeting via WebEx.

Dr. Gardner made a motion to adjourn at 3:12pm and Mr. Roper seconded the motion which passed unanimously.
