# SC Board of Medical Examiners Respiratory Care Committee Minutes

Meeting called to order at 10:01 a.m. (Quorum present)

#### **Respiratory Care Practitioners with Temporary Licenses applying for Permanent Licensure**:

After review, a motion was made to approve applicants with temporary licenses for permanent licensure (**30**). Motion to approve Scott Simms, RCP. Second Christopher Perry, MD. Motion carried.

# Instant Certificates – Tennessee License Holders

Jerry Alewine, Chairman discussed the Tennessee CEU process for its licensees. The Tennessee Board has interpreted the rule providing "minimum of 5 hours must be obtained live, real-time, with interactive opportunity" as requiring licensees by physically "in the room" during the lecture to receive credit. The question was asked if South Carolina should incorporate a minimum number of hours that must be live (in-person) instead of all hours being able to be completed online. After a brief discussion the Committee has decided to leave it as it is and not recommend any changes.

# **Appointment of Committee Members**

Maggie Murdock, Board Administrator explained the process of Committee member appointments. An eblast would be sent to all licensed RCP's and Physicians and recommendations from Committee members and Board members would be collected. Interested candidates would be reviewed and appointed by the Board.

Kyle Tennis, Advice Counsel, spoke on re-appointments of current committee members. Pursuant to S.C. Code Ann. § 40-47-550, no Committee member may serve more than one full four-year term consecutively, but the member is eligible for reappointment two years from the date the full four year-term expires. Additionally, members shall serve until their successors are appointed and qualify. After discussion, Committee members Angela Gildner and Scott Simms volunteered to step down if needed.
