Requirements for Employees Working in Sleep Labs were discussed. The question was posed if there could be training under South Carolina Code section 40-47-530(3) approved by the board on CMA/CNA performing certain duties of an RCP. Discussion focused on whether to allow inhouse training programs from different healthcare organizations or should training be from a formalized training program. The committee agrees training should be formal and not in-house training programs from within a hospital
