5. Committee Recommendations for Vacancies (A-E)

Therin S. Hill, PA, Catherine A. Gillespie, PA, Derek T. Roper, PA and Gregory S. Mangione, PA, all were present to present and answer questions regarding their interest in filling Committee vacancy. After each presentation, Dr. Gardner went on record to make a suggestion to possibly come up with a standing/sub-committee for the Physician Assistant Committee for the other applicants who are not selected for the vacancy. Motion was made by Dr. Gardner to go into executive session to fill the Physician Assistant vacancy. Motion was seconded by Mr. Irvin. All in favored. Mr. Irvin proposed motion to come out of executive session. Dr. Gardner seconded. All favored. Dr. Gardner then presented a motion to have PA Catherine A. Gillespie's name be forwarded to the Medical Examiners Board as the candidate chosen to fill the Physician Assistant position. Motion seconded by Mr. Irvin and all favored. Dr. Gardner moved that physician assistant vacancy nominations be closed. After further more in depth discussion, a motion was made by Dr. Gardner that the names of the other applicants (Therin S. Hill, PA, Derek T. Roper, PA and Gregory S. Mangione) be forwarded to the full board to take into consideration to offer them a standing open invitation to attend quarterly Physician Assistant Advisory Committee meetings for their input to be offered, based on their expertise and knowledge of the PA functions and new PA practice act. Seconded by Mr. Irvin. All favored.

6. Requests for Tele-Medicine

Madeline Wiechec, PA, and Dr. Diana Mullis, MD appeared via teleconference to request Tele-Psychiatry care outside of 60 mile radius to inmates with the South Carolina Department of Corrections. A motion was proposed by Dr. Gardner for approval of Tele-Psychiatry under supervision of Dr. Diana Mullis. Motion was seconded by Dr. Neilsen All favored the motion.

7. Legislative Update to the Physician Assistant Practice Act (A-C)

S132 Physician Assistant Practice Act Bill, Frequently Asked Questions Sheet and new Application Portal were all reviewed and discussed. The new Physician Assistant Practice Act will take into effect officially August 11, 2019. After further discussion about new practice act, Dr. Gardner presented a motion to get better interpretation from the full board on latest statutory language regarding Physician Assistants ability to "delegate the administration of medication to unlicensed assistive personnel." Motion seconded by Dr. Neilsen. All in favor.

8. Chair Report and Administrator's Report

Mr. Spoon informed the Physician Assistant license renewal begins on October 1, 2019 and ends December 31, 2019.

Ms. Green informed pending the board approval election results effective October 11, 2019, Mr. William S.

Irvin will become the new committee Chairman and PA Catherine Gillespie will be the new member of the Physician Assistant Advisory Committee meeting.

Ms. Green made a motion to adjourn at 4:41 p.m. Dr. Irvin seconded the motion which passed unanimously.
