Review and adoption of Agenda. After review the meeting agenda was adopted. Motion by Dr. Saad. Second by Dr. Schabel. Motion Carried.

Review and approval of excused absences. The board approved the absence of Turner on Monday morning, Dr. Chow on Monday morning and Dr. Schabel on Tuesday afternoon. Motion by Dr. Saad. Second by Dr. Welsh. Motion carried.

Approval of August 2017 minutes. After review, the board approved the August 2017 meeting minutes. Motion by Dr. Schabel. Second Dr. Cook. Motion carried.

## President's Report – Stephen R. Gardner, M.D.

- Election of Officers-The board conducted annual election of officers.
   President-Dr. Welsh. Motion Dr. Saad. Second Dr. Schabel. Motion carried.
   Vice-president-Dr. Cook. Motion Dr. Saad. Second Dr. Schabel. Motion carried.
   Secretary-Dr. Saad. Motion Dr. Schabel. Second Dr. Welsh. Motion carried.
- 2. Request for Exception to Transfer Patient Records-Palmetto Adult Medicine/McLeod Physician Assoc. II, Chandler Martin, Esq.
  - Mr. Martin appeared and presented the request. Upon consideration and discussion, the board approved the records transfer. Motion by Dr. Cook. Second Dr. Welsh. Motion carried.
- 3. H3587-Seizure Safety in Schools Study Committee-Appointment of pediatric neurologist. Upon consideration and discussion, the board appointed Dr. Addie Hunnicutt and Dr. Sanjay Nunley as an alternate to this committee. Motion by Dr. Schabel. Second by Dr. Saad. Motion carried.
- 4. Corporate practice of medicine and the oversight of unlicensed personnel-new advisory opinion

The board approved a motion to prepare FAQ for this advisory opinion through counsel. Ms. Coleman will contact the general counsels of S.C. Healthcare associations and other organizations. Motion Dr Saad. Second by Dr. Schabel. Motion carried.

- 5. Margie Heggie, CEO, S.C. Medical Association presented to the board SCMA's third biennial CME compliance report. 4,805 physicians are on record with SCMA as compliant with the drug course requirement. Ms. Meggie reported on the SCMA's procedures for verification of CME and their accreditation process for Category 1 classification as well as approval of medical service volunteer hours to meet the CME requirement for physicians and the approved form for same.
- 6. Telemedicine Practice by Physician Assistants-after review, this item was tabled. Motion to table. Dr. Saad. Second by Dr. Welsh. Motion carried.
- 7. Advisory opinion on Petitions for Reinstatement and Release from terms and conditions. After discussion, the board determined that the conditions under which a respondent may request reinstatement, release from terms and conditions or other order modification will be reflected by the board in the individual order. Motion Dr. Schabel, Second Dr. Dilts. Motion carried.
- 8. Permanent license application-Letters of recommendation [Physicians and Physician Assistants] After discussion, the board approved elimination of this requirement for Physician and Physician Assistant applicants. The board will require the applicant to provide the names of three potential references as part of the application. The board may request a letter of recommendation from the applicant. Motion Dr. Gardner. Second by Dr. Schabel. Motion carried.
- 9. FARB Conference report-Ms. Coleman reported from this conference in Savannah October 5-8, 2017 in Savannah Ga. Topics discussed included the opioid crisis, the North Carolina Dental Board decision presented by an FTC representative and the advice counsel function in other states.
- 10. Cosmetic Procedures-Dr. Chow began the discussion by beginning with the June 9th joint meeting of the Medical, Dental and Nursing boards from which came a joint opinion on Neuromodulators including Botox which has been published. Additional cosmetic procedures such as laser procedures being addressed was discussed. After discussion of the procedures and issues involved, the board directed Dr. Chow along with board counsel to move forward with a similar joint approach involving the other affected boards such as Cosmetology, Dental and Nursing and to report progress to the board at the February 2018 meeting. The materials Dr Chow had previously prepared on the subject were requested to be provided to each board member.
- 11. Controlled substance online prescribing for established patients-Dr. Gardner discussed this issue with the board for information only in relation to the state Prescription Monitoring Program administered by DHEC.

#### Administrator's Report

- 1. Physician Assistant Advisory Committee- After discussion, the board approved the proceedings of the Physician Assistant's Advisory Committee from its October 13, 2017 meeting. The board appointed Dr. Welsh as the *ex officio* member of the committee and Dr. Gardner as a physician member of the committee. Motion Dr. Schabel. Second Dr. Welsh. Motion carried.
- 2. Respiratory Care Practitioner Advisory Committee-After discussion, the board approved the proceedings of the RCP Advisory Committee for the committee's October 20<sup>th</sup>, 2017 meeting. Motion by Dr. Gardner. Second by Dr. Januchowski. Motion carried.
- 3. Acupuncture Committee- After discussion, the board approved the license applications reviewed by the Acupuncture Advisory Committee. The committee did not hold a meeting in this interval. Motion by Dr. Gardner. Second by Dr. Schabel. Motion carried.
- 4. Board Elections Update-Mr. Spoon gave the board an update on board elections. New members include Dr. Dilts, District 5 and Dr. Januchowski, D.O. Seat. Upcoming elections are for Districts 2, 3, 6 and 7.

5. CME Audit Update-After discussion, the board directed counsel for the board to advise the next steps for those not in compliance with the audit.

Legislative Update, Holly Beeson, Rebecca Leach- LLR Office of Communications

Holly Beeson and Rebecca Leach, LLR Office of Communications and Governmental Affairs, updated the board on legislative items of interest. Ms. Beeson reminded the board this is the first year of a two-year session. Legislative items included medical marijuana, the VC Summer legislation, the APRN Bill, pharmacist compounding, and the new CME requirement for PAs and Podiatrists. Ms. Beeson's office will continue to email legislative updates to board members. Ms. Coleman mentioned the South Carolina Behavioral Health Coalition that has been formed addressing reimbursement for Naloxone and Suboxone.
