- Review and discussion of Team based care in Neurosurgery, Stanley O. Skarli, MD, FACS, FAAP, FAANS Vice-Chair, Department of Neurosurgery at Palmetto Health Children’s Hospital, appeared before the committee for approval of a neurosurgery scope of practice to reflect the additional training and skills for this specialty.

After discussion, Dr. Gardner made a motion to **approve** the scope of practice request for Annette M. Darby-Rauch, PA-C to perform insertion of external ventricular drain (**EVD**) being the more advanced procedure, using the identical techniques without cannulating the ventricle, insertion of intracranial pressure monitor (**ICP**), and insertion of central venous access. The board noted that the APRN licensees [Cuff and Jackson] should be authorized for these tasks as well. These Board of Nursing licensees will have to be approved by the Board of Nursing as well. Mr. Irvin seconded the motion. All favored the motion. Motion carried.

- Review and discussion of **Physician Assistant and Supervising Physician Prescriptive Rules, Dr. James L. Bland, MD, JD** appeared before the PA Committee to discuss **PA Practice Act Section 40-47-965 requirements for writing prescriptions for drugs, controlled substances, and medical device.** After discussion, Dr. Gardner made a motion to **accept as information**, he also made a recommendation to review the website **Laws/Policies for Physician Assistants.** Ms. Green seconded the motion. All favored the motion. Motion carried.

- Review and Approval of Physician Assistant Permanent License Interview Package. Dr. Gardner presented the interview package to the PA Committee. When an applicant has a clear and routine application without disciplinary or other issues, the applicant received a temporary license and may receive permanent licensure without an in-person appearance. The supplicant is sent the permanent application package to review. The package includes the ten Interview Statements, Supervision Statement, and the 7-page Welcome letter addressing the Physician Assistant Practice Act 40-47-905 thru 40-47-1020. The Physician Assistant applicant notifies the board and staff, attesting they received the package, and understand its contents including how to contact a board member regarding any licensing, practice or board operation questions should they arise. Staff will conform the administrative process to transition to this process.

After discussion, Ms. Green made a motion to **approve** the Interview Package. Dr. Otruba seconded the motion. All favored the motion. Motion carried.

- Review and discussion of additional proposed standard template Scopes of Practice. The PA Committee reviewed additional standard scope for **Psych and or Behavioral Health.**

After discussion, Mr. Irvin made a motion to **approve** as standard scope as presented by Mr. Irvin. Dr. Gardner seconded the motion. All favored the motion. Motion Carried.

- Physician Assistant Advisory Committee Vacancies and Consideration of Appointments. **Mary Lou Hill** was recommended to replace Consumer Member Cindy Bostic based upon the expiration of the

member term. Dr. Otruba made a motion to **accept** the board Consumer Member for appointment. Dr. Gardner seconded the motion. Motion carried.

10. Chair Report and Administrator's Report

Mr. Spoon and Ms. Green welcomed **Dr. Edward A. Neilsen** as a new PA Committee member. The announcement was made to the PA Committee this would be the last meeting for Consumer Member Cindy Bostic. Mr. Spoon informed PA Committee members to update contact information to include e-mail address, and Congressional District using link <https://eservices.lir.sc.gov/changeofadd/> due to security updates staff will not be allowed to provide this information via telephone or e-mail.

Ms. Green made a motion to adjourn at 3:31 p.m. Mr. Irvin seconded the motion which passed unanimously.
