5. Request for Off-Site Practice

- A. Erin Miller, PA, appeared via teleconference to request Off Site Wound Care approval with no mileage restrictions at specified locations listed on application. A motion was proposed by Dr. Gardner for approval of Border to Border (within South Carolina) under the supervision of Primary Supervising physician Dr. Stegemoller. Motion was seconded by Mr. Irvin. All favored the motion.

6. Committee Recommendations for Vacancies

Potential Physician Assistant Committee Member candidates, Therin S. Hill, PA, Catherine A. Gillespie, PA and newly introduced candidate Brown James McCallum, MD, were discussed by the members in regards to filling PA Committee vacancies. Dr. Gardner made the motion to invite Dr. McCallum to the next PA Committee Meeting in July 2019 for additional consideration. Ms. Mary Lou Hill seconded the motion and all favored. Another motion was presented by Martha Green to invite both PA candidates Hill and Gillespie to the July 2019 committee also. Motion was seconded by Ms. Hampton and all favored.

7. Standard scopes of practice

- A. Dermatology Scope was presented to the committee for clarification of what is needed to obtain Accutane/Isotretinoin prescribing privileges with Isotretinoin being listed as a preapproved task on the Dermatology Standard scope but also needing additional required training through I-Pledge program. After further discussion, a motion was made by Dr. Gardner to amend the Dermatology Standard Scope to now read “Drug therapy which may be prescribed, in accordance with federal and state laws and regulations” with link of I-Pledge website. Motion seconded by Mr. Irvin. All committee members favored.
- B. The Allergy, Asthma and Immunology Scope from Allergy Partners of the Upstate was presented to the committee by Ms. Hampton to possibly use the submitted scope as a model with modifications to create a Standard Board approved Allergy, Asthma and Immunology Scope. After further discussion, committee decided would take that as information.
- C. Urology and Urological Surgery Scope was presented to the committee by Mr. Irvin to remove the pre-approved skill of Bladder Fulguration from the board approved scope. The motion was seconded by Dr. Gardner and the committee all favored of the removal.
- D. Emergency Medicine modified scope from Greenville Health System was presented to the committee administrative to seek approval to automatically redact and approve scope using Mr. Irvin’s already reviewed and approved recommendations of the scope. After further discussion with the members, it was suggested to get in contact with Greenville Health to see if they would be willing to make adjustments to the scope or use the Standard board approved Emergency medicine scope.

8. Chair Report and Administrator's Report

Mr. Spoon informed the Committee that 2019 is year of renewals for physician and physician assistant. The physician renewals are currently going on now through end of June and the Physician Assistant renewals will begin in October.

Ms. Green made a motion to adjourn at 3:05 p.m. Dr. Irvin seconded the motion which passed unanimously.
