CALL TO ORDER

Dr. Bradley Keefer, of Murrell's Inlet, Chairman of the Board, called to order the Special called meeting of the South Carolina Board of Podiatry Examiners to order at 04:01 p.m. on Monday, September, 23, 2024, with a quorum present. Dr. Keefer announced that the meeting was being held in accordance with the Freedom of Information Act by notice to *The State* newspaper, Associated Press, and notices posted on the bulletin boards located at both the main entrances of the Kingstree Building where the Board office is located.

APPLICATION HEARINGS

Kenice Frank, DPM—

Dr. Frank was present along with her attorney, Tracey R. Perlman and answered questions that the Board members asked regarding her initial Podiatry application. Dr. Cahill made a motion to go into Executive Session, Dr. Ravenell seconded. Motion carried.

DISCUSSION ITEM

Approval of Non-renewed Applications—

The Board discussed how they want to handle Reactivation applications which come in after the late renewal deadline. They decided that the Reactivation applicants will need to provide proof of 24 hours of CME every two years which is what would have been required if the licensee had maintained an Active license with the Board. If the license has been lapsed for over five years, then the applicant for Reactivation will need to have a Board appearance prior to approval of the application.
