## CALL TO ORDER

Ms. Julian, Chairperson, called the meeting to order at 10:05 a.m. The meeting was held in Room 108, Kingstree Bldg., 110 Centerview Drive, Columbia, South Carolina.

# ADOPTION OF AGENDA

The October 13, 2011 agenda was presented for review and approval. Ms. Witherspoon motioned to amend the agenda by placing the OIE report after approval of the minutes. The Motion was seconded and approved.

Motion: Ms. Witherspoon made a motion to approve the October 13, 2011 agenda, as amended. The motion was seconded approved.

#### APPROVAL OF MINUTES

## **Application Hearing:**
