## Call to Order

<u>Motion:</u> In open session, Ms. Barrow made a motion to approve the absence of Mr. Warren. The motion was seconded and approved.

## **Approval of the Minutes:**

<u>Motion</u>: In open session, Mr. Bowie made a motion to approve the April 9, 2020, meeting minutes - no corrections noted. The motion was seconded and approved.

#### **New Business**

Office of Investigations and Enforcement (OIE/IRC) Report: Mr. Dean, presented the OIE statistical report to the Board.

The Board accepted the statistical report as information.

Mr. Dean presented the IRC Report to the board. There are six dismissals, four letters of caution and two formal complaints.

<u>Motion</u>: In open session, Ms. Dilts made a motion to allow Ms. Filyaw to continue practice as a physical therapist assistant in South Carolina with continued monitoring by RPP. The motion was seconded and approved.

## Request to be Removed from a prior Board order

**Chiragbhai Aniyali:** The purpose of this hearing is to determine whether Mr. Anyali should be granted a license as a physical therapist in South Carolina. Mr. Aniyali made a personal appearance before the Board by video conference and was not represented by legal counsel.

<u>Motion</u>: In open session, Ms. Dilts made a motion to grant Mr. Aniyali a license to practice physical therapy in South Carolina. The motion was seconded and approved.

**Enelbert Astorga:** The purpose of this hearing is to determine whether Mr. Astorga should be granted a license as a physical therapist. Mr. Astorga made a personal appearance before the Board by video conference and was not represented by legal counsel.

<u>Motion</u>: In open session, Ms. Dilts made a motion to grant Mr. Astorga a license to practice physical therapy in South Carolina upon the condition that he provides a letter documenting his 1,000 hours of supervised clinical practice. The motion was seconded and approved.

<u>Motion</u>: In open session, Ms. Dilts made a motion to rescind the previous motion for Mr. Astorga and amend the motion by issuing a provisional license to practice physical therapy in South Carolina in order to obtain 1,000 hours of supervised clinical practice under the direct supervision of a licensed physical therapist. Mr. Astorga will be issued a full physical therapy license upon the completion of his transitional DPT degree at a CAPTE-approved school. The motion was seconded and approved.

**Pinakin Hinhoriya:** The purpose of this hearing is to determine whether Mr. Hinhoriya should be granted a license as a physical therapist. Mr. Hinhoriya made a personal appearance before the Board by video conference and was not represented by legal counsel.

<u>Motion</u>: In open session, Ms. McMillan made a motion to grant Mr. Hinhoriya a license to practice physical therapy in South Carolina. It was seconded and approved.

**Aruna Maddela:** The purpose of this hearing is to determine whether Ms. Maddela should be granted a license as a physical therapist. Ms. Maddela made a personal appearance before the Board by video conference and was not represented by legal counsel.

<u>Motion</u>: In open session, Ms. Dilts made a motion to go into executive session for legal counsel. The motion was seconded and approved.

<u>Motion</u>: In open session, Mr. Bowie made a motion to come out of executive session. The motion was seconded and approved.

Gourav Miglani: The purpose of this hearing is to determine whether Mr. Miglani should be granted a license as a physical therapist. Mr. Miglani made a personal appearance before the Board by video conference and was not represented by legal counsel.

<u>Motion</u>: In open session, Ms. Dilts made a motion to grant Mr. Miglani a provisional license to obtain 1,000 hours of supervised clinical practice. The motion was seconded and approved.
