Suspension will be stayed and license will be placed on probation for a period of three (3) years. Respondent is required to complete the Unit IIIB course within six (6) months from the

date of the Order, and pay a penalty of \$2000 within sixty (60) days from the date of the Order. Mr. Rinehart seconded the motion, which carried unanimously.
