Sharon Wolfe presented the Commission with an overview of the opened and closed cases from January 1, 2015 – November 12, 2015, as well as for the previous year.

4. IRC Report - The Commission reviewed the IRC report from November 9, 2015.

#### **MOTION:**

Mr. O'Kelley made the motion to approve the Dismissals portion of the IRC report from November 9, 2015. Ms. Pratt seconded the motion, which carried unanimously.

#### **MOTION:**

Ms. Pratt made the motion to approve the Formal Complaints portion of the IRC report from November 9, 2015. Mr. O'Kelley seconded the motion, which carried unanimously.

#### **MOTION:**

Mr. Cox made the motion to approve the Formal Complaints/Cease & Desist portion of the IRC report from November 9, 2015. Ms. Pratt seconded the motion, which carried unanimously.

Mr. O'Kelley made the motion to approve the Letters of Caution portion of the IRC report from November 9, 2015. Mr. Cox seconded the motion, which carried unanimously.

#### **MOTION:**

5. The Commission reviewed the *Commission meeting schedule for 2016*. Discussion was held regarding adding a June 2016 meeting.

**6.** Mr. Atkinson discussed proposed *Criminal Background Approval Delegation* with the Commission. The Administrator would be allowed to approve charges older than seven (7) years old, and consult with the Chair for violent crime offenses. This would prevent the Commission from having to hear every application that has charges over seven (7) years old.

#### MOTION:

Mr. Cox made the motion to grant the Administrator approval discretion on offenses that are grounds for denial over seven (7) years old. The Administrator may consult with Chair on violent crime offenses and fraud/theft/receiving goods over \$500. Mr. Poplin seconded the motion, which carried unanimously.

#### New Business

- 1. The Commission discussed the South Carolina Realtors Contract of Sale as it relates the Earnest Money Deposits. Byron King represented SCR during this discussion.
- 2. Rocky Watts, representative from SR&I, addressed the Commission to discuss details of the contract and to answer questions the Commission had regarding the background check process.
- 3. Election of Officers:
