### Meeting Called to Order:

Chair Pratt called the meeting of the South Carolina Real Estate Commission to order at 10:00 a.m. Board members participating in this meeting included:

## Public Notice:

Chair Pratt announced that public notice of this meeting was properly posted at the S.C. Real Estate Commission Office, Synergy Business Park, Kingstree Building, and provided to all requesting persons, organizations, and news media in compliance with Section 30-4-80 of the South Carolina Freedom of Information Act.

#### Pledge of Allegiance:

The Pledge of Allegiance was recited by all present.

#### **Invocation:**

Invocation was offered by Commissioner Mitchell.

#### **Introduction of Board Members and Staff**

#### Approval of Absences:

W. Brown Bethune  $-7^{\text{th}}$  Congressional District

#### **MOTION:**

Ms. Mitchell made a motion to approve the absence of Commissioner Bethune. Mr. Poplin seconded the motion, which carried unanimously.

## **Approval of Agenda:**

It was noted that the Disciplinary Hearing for Tammy Scoggins has been continued.

## **MOTION:**

Mr. Rinehart made a motion to approve the agenda, as amended. Mr. Lockwood seconded the motion, which carried unanimously.

## **DISCIPLINARY HEARING**

### Jella Kim (MOA)

The Commission held a Disciplinary hearing regarding Jella Kim. Ms. Kim appeared before the Commission to present testimony, and was represented by Catherine M. Cunningham, legal counsel. Rowland Alston, Office of Disciplinary Counsel, represented the State, and presented the facts of the case.

Mr. Rowland informed the Commission that Ms. Kim has signed a Memorandum of Agreement. The Commission reviewed said agreement and discussion ensued.

### **MOTION:**

Mr. Lockwood made a motion to enter Executive Session to receive legal advice. Mr. Lee seconded the motion, which carried unanimously.

### MOTION:

Mr. Lee made a motion to exit Executive Session, where no votes were taken. Mr. Poplin seconded the motion, which carried unanimously.

#### **MOTION:**

Mr. Rinehart made a motion that the State has met its burden of proof that Ms. Kim is in violation of S.C. Code Ann. 40-57-710 (A) (5) (2017 Supp.) and that Ms. Kim be issued a Public Reprimand. Ms. Kim's license will be placed on probation for a period of two years, stayed. Mr. Lockwood seconded the motion, which did not pass.

## **MOTION:**

Mr. Lee made a motion that the State has met its burden of proof that Ms. Kim is in violation of S.C. Code Ann. 40-57-710 (A) (5) (2017 Supp.) and that Ms. Kim be issued a Letter of Caution. Mr. Stackhouse seconded the motion, which carried with a 7/1 vote.

#### James Olszewski

The Commission held a Disciplinary hearing regarding James Olszewski. Mr. Olszewski appeared before the Commission to present testimony, and was not represented by legal counsel. Rowland Alston, Office of Disciplinary Counsel, represented the State, and presented the facts of the case. Discussion ensued.

## **MOTION:**

Mr. Lockwood made a motion to enter Executive Session to receive legal advice. Mr. Lee seconded the motion, which carried unanimously.

## **MOTION:**

Mr. Lockwood made a motion to exit Executive Session, where no votes were taken. Mr. Poplin seconded the motion, which carried unanimously.

Commissioner Mitchell left the meeting at 12:00 noon, however, a quorum was maintained.

## **MOTION:**

Mr. Rinehart made a motion that the State has met its burden of proof that Mr. Olszewski is in violation of S.C. Code Ann. 40-1-110 (1) (a) (2011); S.C. Code Ann. 40-1-110 (1) (b) (2011); S.C. Code Ann. 40-1-110 (1) (f) (2011) and S.C. Code Ann. 40-1-110 (1) (g) (2011). A Public Reprimand will be issued. The license will be placed on suspension for a period of two (2) years from the date of the Final Order. Prior to reactivation, the licensee must satisfy all continuing education requirements. A penalty of \$500 per violation will be imposed, due within ninety days from the date of the Final Order. Licensee will not be able to upgrade to Broker in Charge or Property Manager in Charge without reappearing before the Commission. Mr. Lockwood seconded the motion, which did not pass.

# **MOTION:**

Mr. Burnett made a motion that the State has met its burden of proof that Mr. Olszewski is in violation of S.C. Code Ann. 40-1-110 (1) (a) (2011); S.C. Code Ann. 40-1-110 (1) (b) (2011); S.C. Code Ann. 40-1-110 (1) (f) (2011) The State has not met its burden of proof that that Mr. Olszewski is in violation of S.C. Code Ann. 40-1-110 (1) (g) (2011). A Public Reprimand will be issued. The license will be placed on suspension for a period of two (2) years from the date of the Final Order, stayed. The license will remain on probation for the 2 year period. A penalty of \$500 per violation will be imposed, due within ninety (90) days from the date of the Final Order. If the conditions of the Order are not met, the license will automatically be suspended. Licensee will not be able to upgrade to Broker in Charge or Property Manager in Charge without reappearing before the Commission. Mr. Lockwood seconded the motion, which passed on a 4/3 vote.
