GUIDANCE DOCUMENT- RECENT SETTLEMENT AND SOUTH CAROLINA LAW

Mr. Tennis explained the purpose of the guidance document was to address questions relating to the National Association of Realtor's recent settlement agreement. Paragraph 58 subsection 6 states, unless inconsistent with state or federal law and regulation, all Realtors working with a buyer must enter into a written agreement with that buyer before the buyer tours any home. The NAR agreement requires specific details regarding compensation as well. The Commission wants to publish a guidance document reminding licensees that this conflicts with existing South Carolina law. South Carolina law does not require a written agreement to tour a house. South Carolina icensees must provide the brokerage relationship form to all potential buyers and sellers with whom they have substantial contact. If the guidance document is approved, the guidance document will be posted to the Commission website.

Motion: To enter into executive session for legal advice where no votes will be taken. Moved by Mr. Lee and seconded by Mrs. Mitchell. The motion was carried by unanimous vote.

Motion: To exit executive session and return to open session.
