• CRIMINAL BACKGROUND CHECKS REQUIREMENT – Per SC State Law Section 40-57-115: An applicant for licensure as a salesperson, broker, broker-in-charge, property manager or property manager-in-charge in South Carolina must submit to a state fingerprint-based criminal records check, a national fingerprint-based criminal records check, and a social security number-based criminal records check.
Once the application has been received, the applicant will receive specific instructions from the South Carolina Real Estate Commission Board (SCREC) via email on how to have a fingerprint-based check processed. Do not have fingerprints processed until these instructions are sent directly from the SCREC.
