# Technical and Business Management and Law Portions of Exam Considered the Same or Separate as the Total Number of Three Fails: MOTION

Mr. McLeod made a motion that applicants be allowed three attempts for each part of the Commission's licensing examinations: (1) the Technical part and (2) the Business Management and Law part. As a result, the parts may be taken on separate dates and a failure of one part does not count as a failure of the other part. Applicants must still pass both parts of the examination to become licensed. Mrs. Rhyne seconded the motion, which carried unanimously.

# **Review and Determine Bond Claim Process:**

The Commission will continue to address bond claims if they arise in a disciplinary matter and will consider promulgating a regulation regarding bond claim process in 2023.

# Digital and Electronic Signatures on Bonds, Continuation Certificates, and/or Riders:

- 1. All original bonds must have handwritten signatures for the authorized agent for the Surety and the Principal/Licensee. It can also be a copy of the signature.
- Continuation certificates and/or riders must have a handwritten signature or a copy of a handwritten signature for the Principal/Licensee if the Principal/Licensee's signature is required on the certificate and/or rider.

- 3. Continuation certificates and/or riders must have a handwritten signature or a copy of the handwritten signature for the authorized agent for the Surety if the bond continuation certificate is sent by the Principal/Licensee.
- 4. Continuation certificates and/or riders may have an electronic or digital signature from the authorized agent of the Surety if the certificate and/or rider is sent directly from the Surety.

# S.C. Code Ann. § 40-59-105(C)(2): 2<sup>nd</sup> Offense Citations and Process for Licensed and Unlicensed:

The Commission discussed the procedure for handling 2<sup>nd</sup> offense citations for both licensed and unlicensed persons but postponed any decision until next month's meeting.
