Called to Order:

Mr. Dowd made a motion to suspend Mr. Morgan's registration until such time as he appears before the Commission to show cause for reinstatement. Mrs. Rhyne seconded the motion, which carried unanimously.

Mr. Sanchez-Duarte did not appear. Therefore, the Commission did not take any action.

Owner-Builder Waiver:

Adebusola Shala Keels
