#### **Renewal Instructions**

- 1. Complete all questions and sign and date this renewal application. Incomplete applications will be returned. Application must be typed or printed in black or blue ink only, make any necessary corrections, and attach additional sheets if necessary.
- 2. **Residential Home Builders** must have a current surety bond on file in the amount of \$15,000. The surety bond must be an original (no copies or facsimiles) in the builder's name only and signed by the builder. **If your surety bond has expired, please submit with this renewal application a current continuation certificate or a new surety bond.**
- Residential Home Inspectors If you obtained your Residential Home Inspectors License with a Residential Home Builders License, you must renew your Residential Home Builders License first.
- Return the completed renewal application, Surety Bond (if applicable) and payment made payable to: LLR-SC Residential Builders Commission, PO Box 11329, Columbia, SC 29211-1329. Your application must be postmarked by the Post Office on or before June 30, 2021. After June 30, 2021, you will be required to reinstate your license.
- 5. It is the individual's responsibility to notify this office, in writing of any name and/or address changes. Name changes require a copy of legal documentation(i.e., marriage license, divorce decree court order)
- 6. A returned check fee of up to \$30, or an amount specified by law, may be assessed on all returned funds. All fees are non-refundable.
