Renewal Instructions/Requirements:

- Renewal fee in the form of a check or money order (no cash) made payable to SC Residential Builders Commission. (All fees are non-refundable. A returned check fee of up to \$30, or an amount specified by law, may be assessed on all returned funds.)
- Biennial Renewal / Late Fees:

Renewed/postmarked on or before 6/30/2022: \$160 Renewed/postmarked 7/1/2022 - 6/30/2023: Late Fee \$90 + Renewal Fee \$160 = \$250 Reinstated after June 30, 2023: Reinstatement Fee \$200 + Renewal Fee \$160 = \$360

- After June 30, 2023, your license must be reinstated.
- **Residential Home Inspectors** If you obtained your Residential Home Inspectors License with a Residential Home Builders License, you must renew your Residential Home Builders License first.
- If you have had a legal name change since your initial licensure or since your last renewal, please attach the legal documentation with this renewal form (Marriage Certificate, divorce decree, court documentation).
