 - □ Completed and notarized **Home Inspector's Affidavit(s) OR 120 hour Course Completion Certificate Form** from an organization approved by the SC Residential Builders Commission.
 - □ Include written explanation(s) for any "Yes" answer(s) for questions in the "General Information" section of the application and include any supporting documentation.
 - □ If you answer "Yes" to any questions(s) pertaining to a conviction, you must remit an official Statewide Background Check from the state where the incident occurred in a sealed envelope from the state agency along with your written explanation.
 - □ If applicable, copy of your business Certificate of Existence/Authorization.
