- Biennial Renewal / Late Fees: Renewed/postmarked on or before 6/30/2024: \$160 Renewed/postmarked 7/1/2024 - 6/30/2025: Late Fee \$90 + Renewal Fee \$160 = \$250
- After June 30, 2025, your license must be reinstated: Reinstatement fee \$200 + Renewal Fee \$160 = \$360
