- The Council has 48 licensed soil classifiers, and one certified Soil Classifier-In-Training. Three licenses have been issued since the last Council meeting.
- The Council had a cash balance of \$41,958.23 as of January 31, 2024.
- Statement of Economic Interest form filings are due by noon on March 30, 2024.

Office of Investigations and Enforcement Report

Mr. Rose stated there are no cases in the Office of Investigations and Enforcement.

Investigative Review Conference Report

Mr. Rose stated there is no Investigative Review Conference report.

Office of Disciplinary Counsel Report

Council Member Reports

Mr. Brewington asked about scheduling a field day for professional soil classifiers. Mr. Fincham said there are efforts to create a SC Onsite Wastewater Association that includes soil classifiers, DHEC officials, engineers, and installers. A field day is a good idea to launch this organization.

Mr. Fowler asked about the account for the South Carolina Society of Soil Classifiers. Mr. DeFrancesco said he was the previous treasurer. Mr. Thorp closed the account and donated the \$669.19 balance to an Environmental group at Clemson University.

1. Election of Officers.

2. **Investigative Review Conference (IRC) Member Appointments.** Mr. Rose stated that Agency management would like each Board to have at least three professional members on the Investigative Review Conference. Mr. DeFrancesco expressed interest in serving.

To appoint Dennis DeFrancesco as a professional member of the Investigative Review Conference.

3. Review of Application for Certification as Soil Classifier-In-Training or Licensure as Professional Soil Classifier. Mr. Fowler stated it came to his attention that the Soil Classifier application prohibits Council members from serving as a Professional Reference. This makes it difficult for in-state applicants, because Council members perform 60% - 80% of the work done in the state. Mrs. League, Advice Counsel, stated there are no references to this in law or statute, so the Council can make a motion to revoke this policy. A new statute prevents Boards from asking questions about "moral turpitude," combined with the current Council law and regulations, means applicants must provide employment verifications, and are not required to provide professional references. Council members verifying experience must recuse themselves, if the issue goes to an application hearing.

MOTION: To revise the applications and forms to allow Council members to provide employment

verifications for applicants. Fowler/Brewington/approved.

4. **2024 Legislative Update.** Mr. Rose stated that H.4486 is scheduled for the Senate Medical Affairs Subcommittee meeting on March 13, 2024, at 10 a.m. in the Gressette Building, Room 207. Individuals submitting comments or testimony must do so on behalf of the profession.
