Administrative Report:

The Administrative Report was given by Dr. Melton, with a staffing chart; licensure totals were 1801 licensed veterinarians and 348 licensed veterinary technicians in South Carolina to date. It was announced that the FAQs have been updated and any new updates from the meeting will be added. FAQs act as safe harbor information for the practice of veterinary medicine.

Dr. Ginger Macaulay, Board Member for District 2, was welcomed to her first board meeting. District 6 has an ongoing election at this time.

Online applications for incoming veterinarians and veterinary technicians are currently available. It was noted that Senate Bills 687, 979, and 980 are in the General Assembly again this year and LLR will track the bills for the Board.

The AAVSB Annual Conference will be held in Scottsdale, Arizona September 22 – 24, 2016. The Board voted to send two (2) representatives from the South Carolina State Board of Veterinary Medicine. Dr. Hughes and Mr. Liger were approved by the Board to attend the conference and bring back a report to the Board on what they learn at the conference. Early registration is through July 31, 2016 and it was discussed. Dr. Hughes and Ms. Shealy discussed their experience at the 2015 AAVSB Conference.

Mr. Sitterle presented CE (Continuing Education) Broker information to the Board. Dr. Macaulay and Mr. Liger agreed to participate in a subcommittee to review CE Broker at a later date and to provide feedback at the next Board Meeting about their experience in pilot-testing the software.

Financial Report:

Financial Report was given and accepted as information.

UNFINISHED BUSINESS:

There was none.

NEW BUSINESS:

The Board was asked to recommend eligible veterinarians, ex. former board members or former IRC members to serve as hearing officers or as a hearing panel for disciplinary cases that may arise in the future in which the Respondent requests a hearing. Dr. Melton was asked to contact the nominated individuals to see if they will be willing to serve on this ad hoc committee.

Motion: Dr. Goodson made a motion to recommend hearing officers or a hearing panel. Dr. Fuller seconded the motion. The motion passed.

The Board was asked to ratify names of IRC members to serve for FY 2017. These individuals will review complaints received by the Board against licensed veterinarians or licensed veterinary technicians and make recommendations to the Board based on the Veterinary Practice Act. Board members discussed the current pool of IRC members. No changes were made to the list.

The Board discussed overseas new graduate clinical practice.
